Dear Sir/Madam:

To facilitate compliance with COVID-19-related public health measures, the Arkansas Department of Agriculture purchased or is in the process of purchasing approximately \$215,436.00 in computer equipment, communication equipment, and online payment systems. These measures facilitate telework capabilities for public employees to enable the continuation of critical services by the Department while following recommended health precautions.

The Department was required to purchase \$36,436.00 of computers and related equipment to enable more than 450 of the 579 employees to work remotely. These purchases were necessary to implement the health and safety precautions recommended by the Centers for Disease Control for the protection of the Department's employees. A detailed list of purchased equipment is provided.

To reduce the risk of contamination and the spread of COVID-19 associated with the use of paper checks, the Department is implementing online payment systems for several of its licensing programs for a total approximate cost of \$179,000. With paper checks, staff must be onsite and interact with delivery services and the public to receive the documents. Employees also must remain onsite in many cases to process the checks. These actions increase the exposure for all parties and create unnecessary risks. The \$179,000 cost of the online payment systems for licensing and permitting programs is for five divisions within the Department.

In addition to qualifying as eligible expenses because they improved telework capabilities of public employees, the expenditures meet the criteria as outlined in the guidance for the CARES Act:

- They are necessary expenditures incurred due to the public health emergency with respect to COVID-19
- They were not accounted for in the budget most recently approved as of March 27, 2020
- They were incurred during the period that begins on March 1, 2020 and ends on December 30, 2020.
