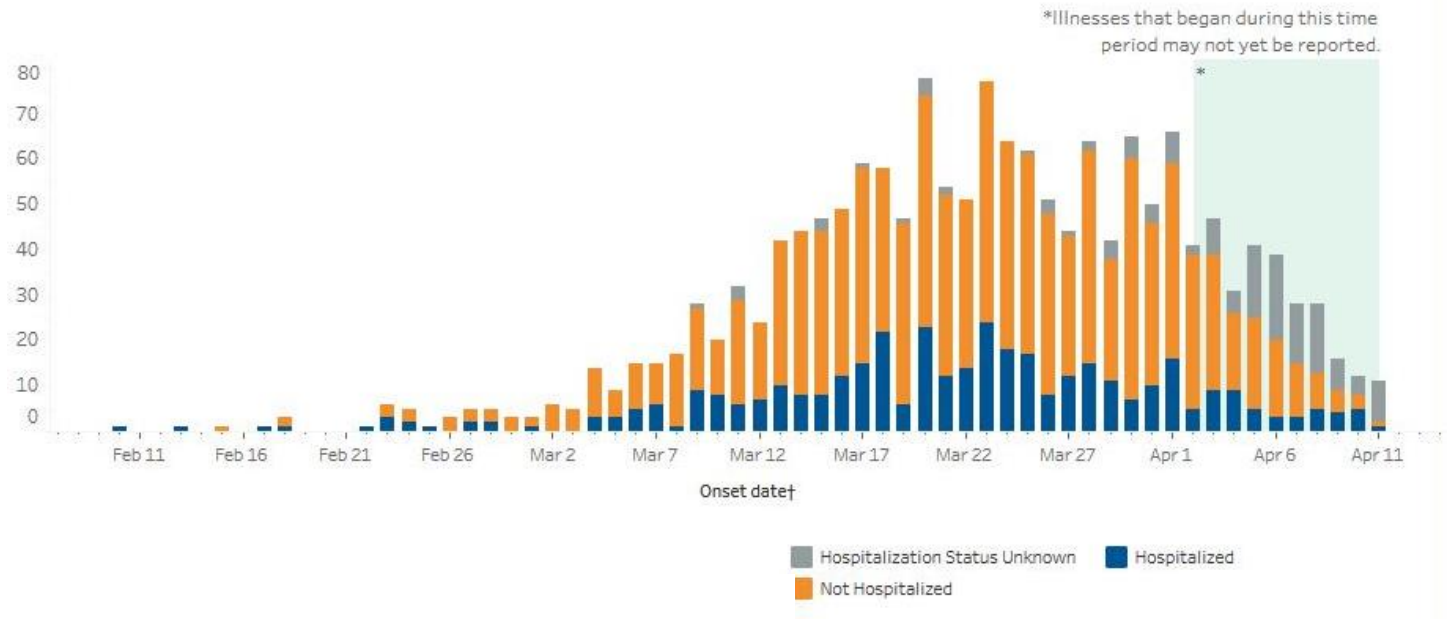

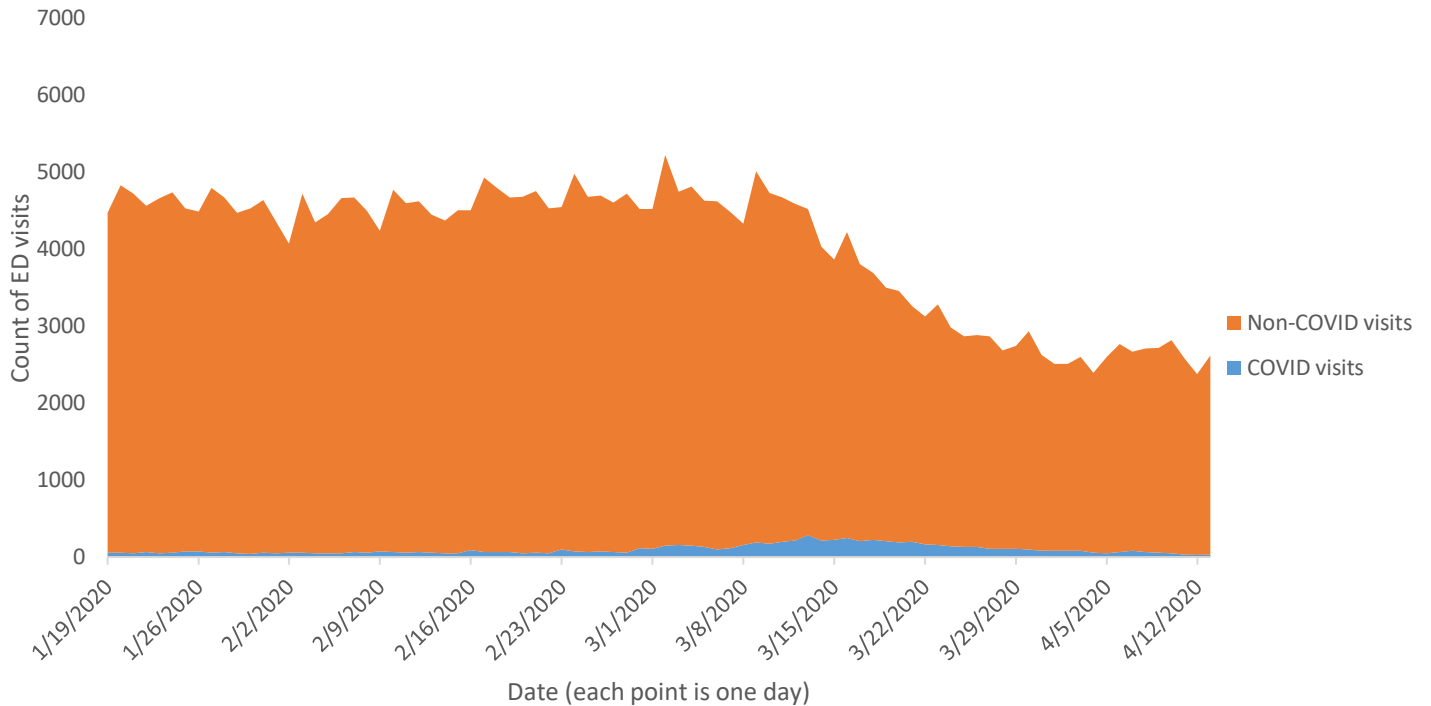

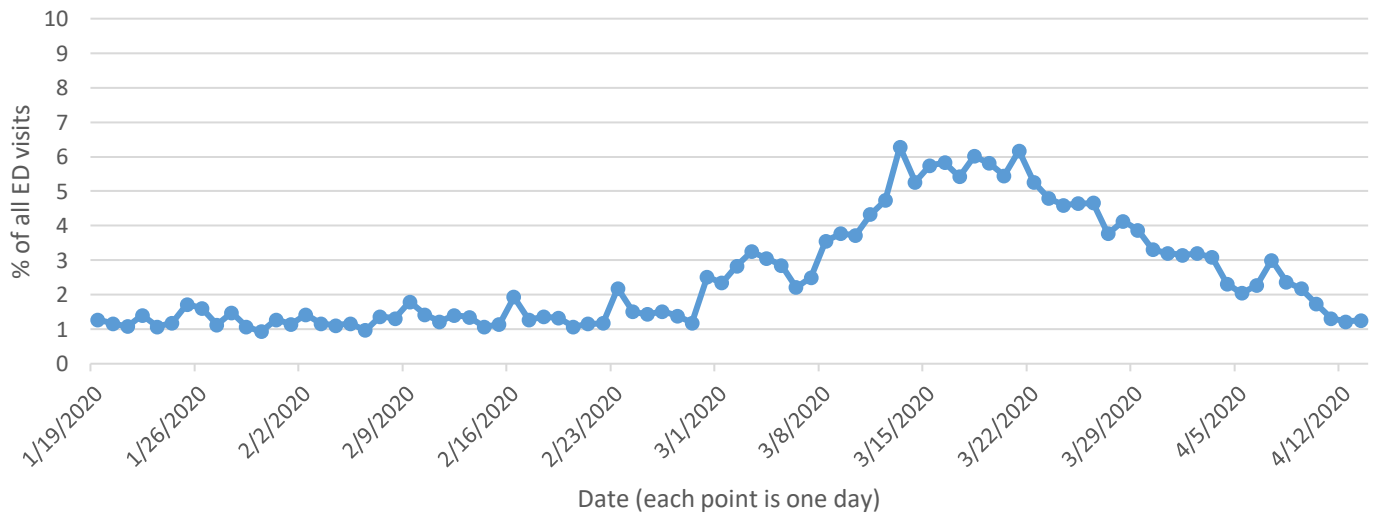


### Emergency Department Visits in Oregon as reported to Oregon ESSENCE\*
