Dear Arkansas CARES Steering Committee:

On March 11, 2020, Governor Asa Hutchinson declared a public health emergency in the State of Arkansas due to the presence of COVID-19 in the state. As of May 26, 2020, 961 inmates at the Cummins Unit and 227 inmates at the Randall L. Williams Unit within the Division of Correction and 63 residents at the Central Arkansas Community Correction Center withing the Division of Community Correction have been diagnosed with COVID-19. Inmates and residents have also been tested at 16 other facilities with no inmate or resident tests coming back positive.

The Department of Corrections (DOC) proposes to use funding made available to the state under Section 601 of PL 116-136, the "Coronavirus Relief Fund" of the Coronavirus Aid, Relief, and Economic Security Act (CARES) to extend the previously approved Hospital and Health Care Facility Care Continuity Incentive (CCI) payments to correctional facility workers whose services are, or have been, substantially dedicated to mitigating or responding to the COVID-19 public health emergency. Payments will be extended to the following groups:

Security personnel assigned to these correctional facilities who regularly came into physical contact with the inmate or resident population:

- 2. Corporal
- 3. Sergeant
- 4. Lieutenant

Public safety was maintained at these locations while managing the pandemic within each facility.

Estimated Cost at \$500 per employee who worked a minimum of forty (40) hours during the pandemic outbreak at their facility:

Cummins Unit - \$191,000

Security - \$159,000

Non-Security - \$32,000

Randall L. Williams Unit - \$79,000

Security - \$63,000

Non-Security - \$16,000

Central Arkansas Community Correction Center - \$31,500

Security - \$22,000

Non-Security - \$9,500
