## Wildfire Response & Recovery Update

September 18, 2020

The Oregon Office of Emergency Management, in coordination with the Oregon Department of Forestry, Oregon State Fire Marshal, Oregon State Police and other state and federal partners, will distribute this daily update, collating verified information on the wildfire response.

#### SITUATION SUMMARY

All major fires on the landscape are at least 10 percent contained. Though not a fire season ending event, rain overnight provided favorable conditions for firefighters. Additional rain and gusty conditions present risks of landslides through the weekend. It's important to stay informed as conditions change. ## Wireless Emergency Alerts (WEAs)

WEAs are delivered straight to your phone via broadcast from local officials. These messages look like a text but have a distinct sound and vibration to help get your attention. Be sure to check your phone settings to make sure these alerts are enabled on your phone. as default options vary by phone and carrier.

### **County Emergency Alerts**

Every Oregon county maintains an emergency alert system to provide local emergency notifications. It is critical Oregonians take the time to opt-in to these local options to ensure they receive these important notifications.

Individual assistance is available to people impacted by fires in Clackamas, Douglas, Jackson, Klamath, Lane, Lincoln, Linn, and Marion counties.


Public assistance is available in Benton, Clackamas, Columbia, Coos, Deschutes, Douglas, Jackson, Jefferson, Josephine, Klamath, Lake, Lane, Lincoln, Linn, Marion, Multnomah, Tillamook, Wasco, Washington and Yamhill counties for publicly owned infrastructure impacted by the wildfires.

Oregon residents impacted by the wildfires and straight-line winds, which began on Sept. 7, 2020 are encouraged to register for disaster assistance with FEMA as soon as possible.
